FUNNY FEELING within striking distance, advanced four wide on the turn, challenged approaching the stretch and proved narrowly best. FUZZY BRITCHES outrun early, advanced in the four path on the turn, angled out for the drive, challenged in midstretch but missed. ELUSIVE JOZI reserved early, commenced her rally in the three path on the turn, altered course in midstretch but lacked a late bid. GLOWING REPORT forwardly placed from the start, challenged three wide on the turn but weakened late. GO FOR JAN alternated for the lead along the inside, held on well to midstretch and tired. OSCAR DE LA THORN outrun to the stretch, improved her position while no threat. WATER OF LIFE within striking distance while off the inside, tired. BRINGINGDOWN BABEL forwardly placed five wide, faded. SOUMA rushed outside, vied for the lead off the inside and faded. ALL COUNTY never menaced.
